Check out time is at **11:00 a.m.** failure to vacate the premises by 11:00 a.m. will result in additional charges. If you will be checking in later than 6:00 p.m. please let us know in advance.

1. A non-refundable \$100.00 reservation fee will be due at the time of booking this rental. Payment on the balance is due 30 days prior to your arrival date. Cancellation of this agreement made prior to 30 days before the first day of occupancy shall result in forfeiture of the reservation fee but no other penalty. Cancellations made within 30 days of the first day of occupancy shall result in forfeiture of the reservation fee and the entire remaining balance and no money shall be refunded. No adjustment in fee will be made if the tenant checks in late or leaves earlier than the agreed upon time. There are no exceptions to this provision.
2. All units are nonsmoking, pets are not allowed. There is a minimum \$50 fee for violation of this rule.
3. Your unit is stocked for the maximum number of people allowed due to fire and safety regulations. With the exception of children under 2 years of age, you will be fined \$50 for each person over the capacity of the room. Recreation vehicles (RV's), campers, tents and other camping equipment may not be occupied on or near premises.
4. Most units do not have phone service.
5. All units are self-keeping. Manager does not provide daily housekeeping service during Tenant's occupancy. Prior to check out, Tenant agrees to: place all dirty dishes in dishwasher and start the cleaning cycle, close and lock all windows and doors, and turn off lights.
6. Each unit is privately owned and decorated with the owner's personal property, any damaged or missing items will be charged to your credit card.
7. Please leave the keys locked inside the unit when you depart.
